PURPOSE AND EFFECT:

Rule 6C1-7.0041 provides that if the College of Medicine imposes a restrictive covenant as a condition of employment, it must be for a period of two years and a radius of fifty miles. The College of Medicine feels the flexibility to impose restrictive covenants for a duration and radius which are reasonable considering the particular employee and specialty at issue.

6C1-7.051 is being amended to update the rule.

SUMMARY:

Rule 6C1-7.0041 gives the College of Medicine the discretion to impose a restrictive covenant which is reasonable under the circumstances up to a maximum period of two years and a maximum radius of 50 miles. No specific changes are made in Rule 6C1-7.051 except that the rule is being published to incorporate the catalogs, bulletins, and brochures applicable for the 1996-97 academic year.
