NOTICE OF PROPOSED RULEMAKING

NAME OF AGENCY: University of Florida

RULE TITLE:

University of Florida; Disclosure and Regulation of Outside Activities and Financial Interests 6C1-1.011

PURPOSE AND EFFECT: The amendments to Rule 6C1-1.011 clarify existing polices and procedure. The approval process for employment by another state agency or for extra employment by the University is clarified. Compensation from the sale of instructional materials is addressed.

SUMMARY: Approval for employment by another state agency or extra state compensation through extra employment by the University of Florida must be accomplished through a University of Florida form separate from that required for other activities outside of the employee's assigned duties. An instructor may not receive personal remuneration for materials developed exclusively for use in the instructor's classroom or other instruction. If the materials are not developed exclusively for the instructor's use, he or she may assign such materials and receive financial benefit as long as appropriate approval is received and reserve copies are provided.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COST: No statement of estimated regulatory costs has been prepared. Any person who wishes to provide information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower cost regulatory alternative must do so in writing within 21 days of this notice.
