PURPOSE AND EFFECT: The amendments clarify existing classifications and procedures and add provisions for multi-year contracts and for endowed professorships.

SUMMARY: Existing classifications and procedures are clarified. Faculty members may be appointed to endowed professorship, including those with the title of eminent scholar. Multi-year contracts (not to exceed five years) may be entered into. Such appointments are not tenure-earning or permanent status earning and may not be made to ranked faculty positions.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COST: No statement of estimated regulatory costs has been prepared. Any person who wishes to provide information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower cost regulatory alternative must do so in writing within 21 days of this notice.
