

**UNIVERSITY OF FLORIDA
NOTICE OF CHANGES IN PROPOSED RULES**

NOTICE IS HEREBY GIVEN that the University of Florida, in response to comments from the Joint Administrative Procedures Committee, has changed the following rules:

6C1-1.008 University of Florida; Disruptive Behavior

In rule subsection (1) following "misconduct," the following change has been made: "as set forth in the rules of the Board of Regents and the University and state law governing such action."

6C1-2.002 University of Florida; Campus Demonstrations

A change has been to the second sentence of subsection (2) as follows: "Any use of sound amplification equipment on the outdoor areas of campus must have prior clearance through the Office of Student Activities at the J. Wayne Reitz Union and will be permitted only if there is no interference of any academic or other University activities."

6C1-2.004 Use of University Facilities; Definitions; Priorities in Use; General Restrictions on Use

In rule subsection (7), the following will be added: "who shall review the request in light of the University's contractual and other legal requirements, the relationship of the activity to the University's mission, and the benefit of the activity to the University and the State of Florida."

6C1-2.005 Use of University Facilities; Outdoor Areas

Rule subsection (2) has been changed to the following: "Approval and scheduling of event in the above areas must be consonant with Rule 6C1-2.004, F.A.C., and other University rules. As a condition of approval, the University may impose safety, security and liability requirements consistent with the use to be made of the area."

6C1-2.008 Use of University Facilities; Instructional Space

The following sentence has been added to the last section of paragraph (1): "Permission for such use shall be granted only when the use is consistent with the academic use of the facilities and any restrictions applicable to the particular space."

6C1-3.025 Administrative Affairs; Lease of Space

A change was made to the second sentence of subsection 4 adding: "which shall remain consistent given the circumstances of the lease."

6C1-3.0371 Administrative Affairs; Fee Refunds

In rule paragraph (1)(g), the University has withdrawn the language concerning the administrative fee of 5% or \$100.00 (whichever is lower).

6C1-4.016 Student Affairs; Student Conduct Code; Violation, Penalties and Procedures for Adjudication

The following language will be added after the second sentence of paragraph (4)(b): "Less serious violations are those violations for which removal from housing, suspension, or expulsion would not be imposed."

6C1-7.041 Academic Affairs; Methods for Review and Resolution of Faculty Grievances

The following was deleted from subsection (4)(c): "a person otherwise authorized to conduct the proceedings".

6C1-7.048 Academic Affairs; Suspension, Termination, and other Disciplinary Action for Faculty: Definitions of Just Cause, Termination, Suspension, and other Disciplinary Action

In rule subsection (4), the words "but is not limited to" have been deleted.

6C1-7.053 Academic Affairs; Florida Museum of Natural History: Use and Loans

The changes made to rule paragraph (1)(b) have been withdrawn.

The following has been substituted for paragraph (1)(c): "Casual photography of exhibits for personal use is allowed except when 'Photograph Prohibited' signs are posted for special exhibitions. Photography for any form of publication or commercial purpose is prohibited unless pursuant to a contract with the University as approved by the Director or the Director's designee. This photography policy will be strictly enforced because of artifact conservation reasons and exhibition contractual obligations."

Except for these changes and certain technical changes, the rules published by the University on February 3, 1998 and March 13, 1998 will be adopted as originally proposed.
