PURPOSE AND EFFECT: To clarify and amend policies for University of Florida student groups, including those for discipline, involuntary withdrawal, student conduct code, and housing, and to clarify policy regarding commercial activities on campus.

SUBJECT AREA TO BE ADDRESSED: Modification of sorority and fraternity judicial structure; clarification of policy involving commercial activities on campus; amendments to student judicial procedures and Student Conduct Code; amendments to rule addressing involuntary withdrawal for medical or psychological reasons; establishment of residential judicial programs for village communities; amendment to University of Florida, Division of Housing Rules and Regulations to address conduct resulting in injury to self, and modification of terms of rental agreement between University and student regarding married and single student housing.
