NOTICE OF PROPOSED RULEMAKING**

NAME OF AGENCY: University of Florida

RULE TITLE:

Use of University Facilities; Outdoor Areas

University of Florida; Use of University Facilities; Fees for Use and Admission Charges

PURPOSE AND EFFECT: Rule 6C1-2.005 is amended to refer to the form that registered student organizations must use in gaining approval for the formal use of outdoor areas and to clarify the use of certain outdoor areas. Rule 6C1-2.012 is amended to allow the charging of fees for library use for members of the general public and clarifies that fees may be charged for the use of outdoor areas on campus.

SUMMARY: A form for registered student groups that desire to schedule the formal use of outdoor areas is incorporated by reference. Informal use of outdoor areas not committed to a specific use or assigned to a specific university agency may be used in an impromptu manner by individuals who are held responsible for their orderly behavior and who do not disrupt university activities or rules or pedestrian or other traffic on campus. The charging of fees for the use of University facilities includes the charging of fees for the use of outdoor areas when the use is permitted. Borrowing fees of \$40.00 per semester or \$100.00 per year will be charged to members of the general public for use of the University Libraries. Members of the University of Florida Alumni Association or the Howe Society shall pay \$30.00 per semester or \$75.00 per year. Individuals paying this fee shall be entitled to borrow up to ten items for a 3-week loan period, but shall not be entitled to remote access to databases licensed by the Libraries or the use of interlibrary loan.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COST: No statement of estimated regulatory costs has been prepared. Any person who wishes to provide information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower cost regulatory alternative must do so in writing within 21 days of this notice.
