PURPOSE AND EFFECT: Rule 6C1-7.013 is amended to state the established University practice that notice of non-reappointment for non-tenured or non-permanent status faculty members may be issued at any time during employment. Rule 6C1-7.051 is being amended to update the rule.

SUMMARY: Rule 6C1-7.013 expressly states that notice of non-renewal or non-reappointment may be issued at any time during the employment of non-tenured or non-permanent status faculty members. The amendments to Rule 6C1-7.051 incorporate the catalogs, bulletins, and brochures applicable to the 1999-2000 academic year.
