UNIVERSITY OF FLORIDA NOTICE OF CHANGE IN PROPOSED RULES

NOTICE IS HERBY GIVEN that the University of Florida, in response to comments received from the Joint Administrative Procedures Committee, has changed the following rules:

6C1-3.047 Administrative Affairs; University Support Personnel System; Disciplinary Procedures

Paragraph (3)(e), the following phrase has been added to the end of the sentence after "State Policy on Alcoholism": "Administration Commission Memorandum 73-20, a copy of which is available from University Personnel Services."

Administrative Affairs; University Grievance Procedures for Administrative and 6C1-3.051 Professional Staff Members: General Information, Definitions, Resort to Other Procedures, Time Limits and Procedure

Paragraph (5)(a), the following phrase has been added to the end of the first sentence: "incorporated herein by reference." The beginning of the second sentence now reads: "A copy of this form"

Paragraph (6)(b) now reads as follows: "The Vice President for Administrative Affairs or the Vice President's designee will conduct a Step 2 review or refer the grievance to the appropriate Vice President for a Step 2 review."

The first sentence of paragraph (6)(c) now reads as follows: "The Step 2 review will be based solely on the Step 1 report or also include a meeting with the grievant if insufficient information is obtained from the grievant at Step 1."

6C1-3.056 Administrative Affairs; Resignation and Non-reappointment of Administrative and Professional Staff

The following sentence has been added as the second sentence of paragraph (2)(f): "Such reassignment will occur when it is determined that such action best meets the employment needs of the department or unit."

Administrative Affairs; Pay Upon Appointment; University Support Personnel System Employees

Paragraph (3)(a), the word "if" has been added after "available" and the comma has been deleted.

Paragraph (3)(c), third paragraph, the second sentence now reads as follows: "The demotion may be with or without a reduction in base rate of pay depending on the employment needs of the department or unit, but the pay shall not be increased and shall not exceed the maximum of the pay range to which appointed."

Paragraph (3)(d), the following phrase has been added to the end of the second sentence: "depending on the employment needs of the department or unit."

Paragraph (4)(c), the word "may" has been changed to "will" in the first sentence and the following phrase has been added at the end of the first sentence: "if it is determined that such action best meets the employment needs of the department or unit."

6C1-4.004 Student Affairs: Social Fraternities and Sororities

Paragraph (1), the following sentence has been added to the last paragraph: "The criteria are set forth in "Fraternity and Sorority House Director Policy, 8/13/99, incorporated herein by reference."

Paragraph (2), the following has been added to the end of the second sentence: "which are the "Fraternity and Sorority House Director Policy and the Alcohol and Social Functions Policy, rev. F98, which is incorporated herein by reference and can be obtained from the Dean of Students Office."

Sections "240.1235" and "240.262" have been added to "Specific Authority."

Section "240.1235" has been added to "Law Implemented."

6C1-4.006 Student Affairs; Commercial Activity; Selling of Merchandise, Activities Involving Off-Campus Vendors

Paragraph (5), seventh sentence, the word "may" has been changed to "will." The following phrase has been added to the end of the seventh sentence: "only in unusual circumstances and only when the group is programmatically associated with that area."

Paragraph (7), the following phrase has been added to the end of the fourth sentence: "and would be made only in unusual cases in which it is determined that the overall benefit to University programs justifies the exception."

Student Affairs; Student Conduct Code; Violations, Penalties and Procedures for Adjudication

Paragraph (2), second sentence, the word "may" has been deleted.

Paragraph (3), first sentence, the word "may" has been changed to "will" in the first sentence. The second sentence now reads: "The following criteria will be used to determine if a student group or organization is to be held collectively responsible for the action or actions of individuals when the action or actions result in a violation of the Student Conduct Code by those associated with the group or organization."

Paragraph (3)(a), the following phrase has been added to the beginning of the sentence: "the action or actions resulting in the violation."

Paragraph (3)(b) now reads as follows: "the group or organization or its leaders, officers or spokesman failed to take responsible precautions against the action or actions resulting in the conduct violations."

6C1-4.0162 Student Affairs; Student Conduct Code; Immediate Suspension Pending Hearing

The first paragraph has been changed to read as follows: "The Director of Student Judicial Affairs has the authority to determine if a violation of Rule 6C1-4.016(1) warrants the immediate suspension of a student or a student organization's privileges. The criteria to be used by the Director of Student Judicial Affairs in making this determination are."

Paragraph (a), the word "whether" has been added to the beginning of the sentence.

Paragraph (b), the word "whether" has been added to the beginning of the first sentence. The phrase "Upon making such a determination," has been added to the beginning of the second sentence. The words "may" have been changed to "will" in the second sentence. In the third

sentence of paragraph (b), "or student" has been added before "organization."

6C1-4.021 Student Affairs: Residence Hall Conduct Hearing Authorities

In the third sentence of paragraph 3, the word "may" has been changed to "will" and the phrase "has no prior violations" has been added before "accepts" and the phrase "and agrees to the sanction" has been added at the end of the sentence.

6C1-4.036 Student Affairs: Involuntary Withdrawal

Paragraph (3), the word "may" has been changed to "will" in the first sentence. The following phrase has been added after the word "matter" in the second sentence: "and shall be offered the opportunity to provide." The proposed language "The temporary withdrawal may be terminated upon receipt by the University of" has been removed.

Sections "240.132(1)" and "240.261" have been added to "Specific Authority."

Sections "240.132, 240.133, 240.261(2), and 240.262" have been added to "Law Implemented."

Except for these changes, the rules published by the University on March 16, 1999 will be adopted as originally proposed.
