PURPOSE AND EFFECT: To clarify and amend policies for University of Florida students and student groups, including those for records, discipline, grievance procedure, student conduct code, and housing.

SUBJECT AREA TO BE ADDRESSED: Modification of sorority and fraternity judicial structure; amendments to student judicial procedures and Student Conduct Code; amendment to University of Florida, Division of Housing Rules and Regulations; clarification of what is included as directory information in student records; amendments to grievance procedures for students; and retention of student disciplinary records.
