PURPOSE AND EFFECT: The amendment changes the method of selection for the Academic Personnel Board from election by the Faculty Senate to appointment by the Provost and updates the University's Guidelines and Information regarding the Tenure, Permanent Status and Promotion Process for 2000-2001.

SUMMARY: The five faculty members of the Academic Personnel Board will be selected by the Provost rather than the Faculty Senate.
