**PURPOSE AND EFFECT: 6C1-6.015:** The amendments clarify the general time guidelines for IFAS faculty outside activities that involve a financial interest. Provisions concerning expert witness consulting, intellectual property, and teaching at community colleges are clarified. **6C1-6.016:** The amendments clarify policies on visitation and use of IFAS properties.

**SUMMARY: 6C1-6.015:** In general, involvement of IFAS faculty in outside activities in which they have a financial interest should not exceed 52 days in a fiscal year. Generally, IFAS faculty and administrative and professional TEAMS employees are not allowed to act as expert witnesses in the state of Florida. IFAS faculty are not permitted to engage an outside activity involving a personal financial interest when intellectual property rights are not consistent with the University's Intellectual Property Policy. **6C1-6.016:** Use of IFAS facilities by outside groups is restricted to organizations that have direct relationships with IFAS. Fees for use are authorized.
