PURPOSE AND EFFECT: Rule 6C1-2.005 is amended to incorporate the current form that is incorporated by reference and change the name from “Special Events/Fund Raising Form” to “Program Planning Form”. The amendment to Rule 6C1-2.012 allows for the photographic reproduction of materials owned by the University of Florida Libraries for a fee and with appropriate permissions secured by the requestor. Rule 6C1-2.0161: Changes to the rule and permit application clarify existing procedures regarding the hanging of banners on the University of Florida campus.

SUMMARY: The amendments to Rule 6C1-2.005 incorporate the current form that is incorporated by reference and change the name from “Special Events/Fund Raising Form” to “Program Planning Form”. The amendment to Rule 6C1-2.012 provides a fee schedule for the photographic reproduction of library materials. The requestor must secure all permissions and indemnifies the university against any claim arising from the reproduction. 6C1-2.0161: Permits will be approved no more than twenty days (rather than thirty) before the banner is to be hung. Banners must be hung no less than one foot above the ground. Banners will no longer be allowed in the parking lot located in the corner of Woodlawn Drive and Stadium Road, but will now be allowed in the North Lawn of the Reitz Union.
