PURPOSE AND EFFECT: **6C1-2.0031:** The rule refers to the new pay plan designations of Academic Personnel and Technical, Executive, Administrative, and Managerial Support (TEAMS). **6C1-2.012:** The amendments revise the borrowing fees for University of Florida library users who have no affiliation with the University. **6C1-2.019:** The amendments limit the authority of the President and the Director of Protocol to give written permission for the sale, service, consumption, or possession of alcoholic beverages.

SUMMARY: **6C1-2.0031:** The rule refers to the new pay plan designations of Academic Personnel and Technical, Executive, Administrative, and Managerial Support (TEAMS). **6C1-2.012:** Fees charged for one semester are to be charged for four month periods. **6C1-2.019:** Subsection (3) is amended to forbid issuing any permits for locations not specified in the rule for the sale, service, consumption, or possession of alcoholic beverages during the University's normal business hours, 8 a.m. to 5 p.m.
