PURPOSE AND EFFECT: **6C1-4.002:** The rule is being amended to clarify student government's authority for recommending allocations of student activity and service fees. **6C1-4.0161:** The amendments clarify and update this rule to conform to the governance structure and statutory wording of the hazing provision in the School Code Rewrite. **6C1-4.017:** The amendments eliminate the reference to the pledge on the "Course Request Registration Form" because the form is no longer used.

SUMMARY: **6C1-4.002:** The amendments to this rule update and clarify references to student government's authority for recommending student activity and service fee allocations. **6C1-4.0161:** The statutory "definition" of hazing is corrected, and the reference to the Board of Regents eliminated. **6C1-4.017:** The amendments eliminate the reference to the pledge on the "Course Request Registration Form" because the form is no longer used.
