**PURPOSE AND EFFECT: 6C1-1.011:** The amendments would require all employees to adhere to the same outside activities and financial interests disclosure and approval process currently required of faculty and exempt TEAMS employees. **6C1-1.101:** Annual pay adjustments and lump sum payments to faculty may be made in accordance with an established faculty compensation plans of the College of Medicine, College of Dentistry, or the College of Pharmacy.

**SUMMARY: 6C1-1.011:** The amendments would require all employees to adhere to the same outside activities and financial interests disclosure and approval process currently required of faculty and exempt TEAMS employees. **6C1-1.101:** Annual pay adjustments and lump sum payments to faculty may be made in accordance with an established faculty compensation plans of the College of Medicine, College of Dentistry, or the College of Pharmacy.
