## **PURPOSE AND EFFECT:**

**6C1-1.0102:** The rule sets forth the University's information technology policies: Acceptable Use of Computing Resources Policy, Information Technology Security Policy, and Spam Policy.

**6C1-1.015:** The amendments clarify the requirement of the submission of an IRS Form 990 by applicants for participation in the University of Florida Community Campaign.

6C1-1.200: Identifies University of Florida holidays and paid days off.

**6C1-1.201:** The amendments refine the definition of Executive Service, establish policies for accepting the transfer of sick leave from state agencies, and limit the leave available for Workplace Injury Leave to 40 hours.

### **SUMMARY:**

**6C1-1.0102:** The rule sets forth the University's information technology policies: Acceptable Use of Computing Resources Policy, Information Technology Security Policy, and Spam Policy.

**6C1-1.015:** An organization wishing to participate in the University of Florida Community Campaign must file an IRS Form 990 or an IRS Form 990EZ with the first two pages of the IRS Form 990.

**6C1-1.200:** The amendments identify University of Florida holidays and paid days off.

**6C1-1.201:** The amendments refine the definition of Executive Service, establish policies for accepting the transfer of sick leave from state agencies, and limit the leave available for Workplace Injury Leave to 40 hours.
