

NOTICE OF PROPOSED RULEMAKING

PURPOSE AND EFFECT:

6C1-2.003: The amendments provide that non-university groups and persons will be allowed to pass out printed material only at Turlington Plaza, Plaza of the America, and the north lawn of the J. Wayne Reitz Union.

6C1-2.012: A charge of \$50.00 shall be assessed in each fall and spring semester to a student requiring processing of a certificate of eligibility for F-1 or J-1 student status and enrollment status verification services.

6C1-2.019: The amendments allow the sale and/or service of alcoholic beverages at additional locations.

SUMMARY:

6C1-2.003: The amendments provide that non-university groups and persons will be allowed to pass out printed material only at Turlington Plaza, Plaza of the America, and the north lawn of the J. Wayne Reitz Union.

6C1-2.012: A charge of \$50.00 shall be assessed in each fall and spring semester to a student requiring processing of a certificate of eligibility for F-1 or J-1 student status and enrollment status verification services.

6C1-2.019: The rule amendments allow the sale of alcoholic beverages at the Mary Ann Cofrin Pavilion of the Harn Museum of Art. Service of alcoholic beverages is permitted at the University Golf Club, Bull Gator Level, Press Box Lounge, Champion Club Lounge, Suites Level 6 and 7, and Austin Cary Memorial Forest, under the conditions imposed by the appropriate administrator.
