

NOTICE OF PROPOSED RULEMAKING

PURPOSE AND EFFECT:

6C1-4.004: The amendment adds the University of Florida Requirements for Fraternities and Sororities to the list of policies with which fraternity and sorority governing organizations must comply in the areas of chapter administration, student development, alumni and public relations, and diversity awareness.

6C1-4.007: The amendment expands the categories of publicly available information about students. **6C1-4.019:** The amendment revises membership criteria for Student Conduct Committee hearing committees. **6C1-4.026:** The amendment reduces the retention term for student disciplinary records to six years.

SUMMARY:

6C1-4.004: The amendment adds a new policy setting forth requirements for fraternities and sororities in the areas of chapter administration, student development, alumni and public relations, and diversity awareness.

6C1-4.007: The amendment adds “most recent previous educational institution attended” and “honors” to the list of public information about students. **6C1-4.019:** The amendment enlarges the number of members of a Student Conduct Committee hearing committee to seven, and establishes a quorum of five. **6C1-4.026:** The amendment reduces the retention term for student disciplinary records from nine to six years.
