PURPOSE AND EFFECT:

6C1-4.004: The rule is being amended to revise the University of Florida Chapter Facility Policy.

6C1-4.009: Amends the procedures for using the services of the Career Resource Center.

6C1-4.012: Amends student grievance procedures to incorporate the University's non-discrimination policy.

6C1-4.016: Rule 6C1-4.016(1)(i) is being amended to incorporate the 2004-2005 edition of the University of Florida Division of Housing Rules and Regulations.

6C1-4.031: The rule is being amended to update the residence hall agreement forms.

6C1-4.032: The rule is being amended to modify the documentation requirements for students occupying University graduate student housing.

SUMMARY:

6C1-4.004: The rule amends the University of Florida Chapter Facility Policy to establish standards, processes, and compliance requirements for exterior maintenance of fraternity and sorority chapter houses.

6C1-4.009: The registration process is amended, and the required fee for using the services of the Career Resource Center is eliminated.

6C1-4.012: The amendments incorporate the University's non-discrimination policy, Rule 6C1-1.006, F.A.C., into the subjects for student grievances.

6C1-4.016: Rule 6C1-4.016(1)(i) is being amended to incorporate the 2004-2005 edition of the University of Florida Division of Housing Rules and Regulations.

6C1-4.031: The rule is being amended to update the University's residence hall agreement forms.

6C1-4.032: The rule is being amended to modify registration certificates required for graduate student housing to include families and single residents.
