

## NOTICE OF PROPOSED RULEMAKING

**NAME OF AGENCY:** University of Florida

**RULE TITLE:**

University of Florida; Possession and Use of Firearms  
Finance and Administration; Identification Card Program

**RULE NO.:**

6C1-2.001

**PURPOSE AND EFFECT:**

**6C1-2.001:** The amendments clarify the application of the prohibition of firearms on University property. **6C1-2.0031:** The rule is being amended to increase the cost of the Gator 1 card from \$10.00 to \$15.00 for all employees and students.

**SUMMARY:**

**6C1-2.001:** Firearms stored under the provisions of the rule should be unloaded prior to storage and return. Approval for use in academic programs must also be provided by the Vice President for Finance and Administration. **6C1-2.0031:** The rule is being amended to increase the cost of the Gator 1 card from \$10.00 to \$15.00 for all employees and students.
