

## NOTICE OF PROPOSED RULEMAKING

**PURPOSE AND EFFECT:**

The rule amendments to Rule 6C1-4.013 add two positions (Residence Life Coordinator and Coordinator for Village Community Services) to the list of persons designated to hear disciplinary proceedings for alleged violations of University Housing rules. Rule 6C1-4.016(1)(i) is being amended to incorporate the 2002-2003 edition of the University of Florida Division of Housing Rules and Regulations. The amendments to Rule 6C1-4.021 revise the disciplinary procedures pertaining to alleged violations of the University's housing rules to accommodate staffing title changes within the Division of Housing. Specific responsibilities related to the new titles of Residence Life Coordinator and Coordinator of Village Community Services are stated. The proposed Rule 6C1-4.038 states that the services and benefits available to eligible students and their spouses or their domestic partners and their dependent children are set forth in the Undergraduate and Graduate catalogs and the student government sponsored insurance. The criteria for determination of domestic partner and dependent children status is incorporated by reference.
